Completed the registration, drivers can scan QR code on the e-vehicle permits issued by the organiser via the App and getting a 'ticket' and QR code to enter loading area of HKCEC.

- Showing the e-vehicle permit is not able to access loading area of HKCEC. Drivers have to use the "Go HKCEC" App to scan QR on e-vehicle permit for obtain a 'ticket'. 直接出示電版車証,車輛不能進入會展卸貨區。司機須下載"會展快運易"手機應用程式,登記後以該程式掃瞄車証上的二維碼以取籌號及進場二維碼。
- Each e-Vehicle Pass are for one-time access on the designated date only (i.e., one QR Code for one entry only) and will be invalid after the exact date of entry.
 各張電子版車輛通行證只限於指定一天使用一次*,逾期無效。(*如該張電子版車輛通行證已於指定日子使用一次進入卸貨區,即三維碼已被掃瞄一次,承建商或貨運代理將不能再次使用同一張電子版車輛通行證進入卸貨區。)
- After arriving at the HKCEC Loading Dock (Phrase 1), please show the QR code on the "Go HKCEC" App via mobile phones to Security to enter the loading dock.

- e-Vehicle Pass are for loading and unloading only. No Parking is allowed. Maximum time limit is 60 minutes. Private vehicles are not permitted to enter the loading area.

- Physical Vehicle Pass will NOT be available on the spot.
